4. **Current Situation Report** – (Discussion Only) – Chair, Caleb Cage, to lead a discussion with the Task Force regarding the current situation for COVID-19 throughout the state, including statewide standards as established under state directives issued by the Governor.
5. **Update on Nevada’s Roadmap to Recovery Transition Plan** – (Discussion Only) – Chair, Caleb Cage, to lead a discussion with the Task Force regarding the state plan to transition to local authority by May 1, 2021.
6. **Update on State COVID-19 Vaccine Distribution Plan and Flu Vaccine Update** – (Discussion Only) – Candice McDaniel, Health Bureau Chief, Nevada DHHS, and Shannon Bennett, Immunization Program Manager, Nevada DHHS, will provide an overview of Nevada’s plan to distribute the COVID-19 vaccine throughout the state, which is currently pending federal approval. An overview of the status of flu, and flu vaccines, in the state will also be provided.
7. **Update on State COVID-19 Vaccine Equity and Outreach Plan** – (Discussion Only) – Chair, Caleb Cage, to lead a discussion with the Task Force regarding the status of statewide equity and outreach efforts with respect to Nevada’s vaccination effort.
